1. *DISTRICT GOALS: 2016-2017

RESOLUTION 000-2016 "WHEREAS, the Board of Education reviewed the following at the August 16th board meeting.

BE IT RESOLVED, that upon the recommendation of the Superintendent, the Lincoln Park Board of Education approves the Lincoln Park Public Schools District Goals for the 2016-2017 school year:

- The district will continue to focus on improving the math instruction, as it moves into the second year of the new math textbook series. The district will look to improve the overall scores on the math portion of the PARCC assessments. At least four percent of the students will show one level of improvement on the 2016-17 PARCC assessment. The individual score reports will be utilized to calculate the progress.
- The district will complete residency verification for the entire district. This will include all students attending Lincoln Park Schools as well as any student the district pays tuition for or provides transportation or aid in lieu. 100% of the students residing in Lincoln Park will be required to complete the residency verification process.
- The district will complete a review and revision of the district's policy manual. This will assure that all policies and regulations are up to date and compliant with all State Codes and Statutes. Once completed the policy manual will be placed on the district website providing access to the community.
- With the increase in services provided in both schools, additional educational space is needed. The district will look to provide the educational space by engaging in a construction project during the 2016-17 school year, providing additional space. The stage area at the LPES will be converted to one regular classroom and one small group instruction room. This will be accomplished with using money in the capital reserve account and not needing to go out for a referendum. The project will be completed for the start of the FY18 school year.
